The meeting was called to order at 4:00 PM. The agenda was approved as presented.

Out-of-State Field Trip – Gettysburg, PA/Washington D.C. – May 10–16, 2017

Mr. Berryhill presented information on behalf of Mr. Shattuck regarding the 8th Grade Social Studies trip. Questions regarding then number of chaperones and students, as well as priority in registration, were addressed. The committee reviewed and recommended approval of the request.

Out-of-State Field Trip – Sandusky, OH, May 26, 2017

Mr. Jones presented information on behalf of himself and Mr. Shoemaker regarding the 11th Grade Physics trip to Cedar Point. It was noted that last year, the trip did not occur due to low numbers. The trip also will be available to AP Physics students (12th Grade) this year since these students would not have attended last year. The committee reviewed and recommended approval of the request.

Out-of-State Field Trip – Indianapolis, IN, October 24–27, 2017

Mr. Delbridge presented information on behalf of Mr. Barnum regarding the FFA trip to the National Convention. Pending further clarification on costs and appropriate signatures on the request, the committee recommended approval of the request.

Out-of-State Field Trip – Vero Beach, FL – Dodgertown April 1-9, 2017

Coach Scott Berman presented information regarding the high school spring training trip to Dodgertown in Vero Beach, FL. The committee reviewed and recommended approval of the request.

Policy #8310 – Student Transportation

The committee discussed Policy #8310. Significant discussion took place regarding the criteria for determining eligibility for student transportation services and the conditions for exceptions to the policy. Mr. Doty provided valuable information regarding transportation services. The committee does not recommend any changes to Policy #8310 or granting an exemption.

The committee discussed draft policies 3000-5000. The committee recommends further discussion and revisions on the 5000 series. The committee recommends sending policy series 3000 and 4000 to the Board for first reading.
